While passing the provisional order certain terms and condition mantion by the FRC one of such condition that is condition No.5 was that if the school aggrieved by the provisional fees determined by the FRC, the school has a right to file objections before the FRC within 7 days from the date of receipt of the provisional order.
- 3. Since the provisional fees determined by the FRC are acceptable to the school and the letter of acceptance is also on the record of FRC, there is no need to pass any detailed order. Hence following final fee determined by the FRC as per the provisional order for the A.Y: 2021-22.

 You are further directed that any excess fees charged from the students over and above the above mentioned ceiling shall have to be refunded to the students.

Terms and conditions:

- 1 The school is not permitted to collect fees more than the final fees determined for the academic year: 2021-22.
- 2 The school is permitted to collect the fees for the academic year 2022-23 and 2023-24 by adding 5% increase in the final fees determined by the committee for the academic year 2021-22. (Subject to in future any Government Resolution passed by the Education Department regarding the declared any celling limit of

Fee Structure due to Covid – 19 Situation.) Which is binding to the School on and above the order of the FRC.

- 3 It is further made clear that the School is not permitted to collect fees under any head other than the head of tuition fees, term fees as permitted and admission fees of 1 month only in case of new admission and thereby causing any extra burden on the students. However, total of all these fees should not exceed the final fees determined by the committee.
- 4 It is also made clear that the School should either return the excess fees collected by the School for the year 2021-22 or give adjustment thereof, in the remaining installments of fees of 2021-22.
- 5 Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- 6 If the School Management has any grievance against the final fees determined by the Committee, it shall have a right to file revision application before the Fee Revision Committee along with challan of Rs.10,000/- by way of filing fees.
- 7 The School is directed to place the final order determining the final fees on its notice board as well as its website respectively in Gujarati and English.
